Key Immigration News

Russia

The entry of foreign citizens into Russia is restricted until further notice. Nevertheless, there are some exceptions. The following categories of foreigners are exempted from travel restrictions into Russia:

- Foreigners who are spouses, children, or parents of citizens of the Russian Federation
- HQS from approved list
- Foreign specialists involved in the commissioning and the maintenance of equipment of foreign production and are included in the approved list
- Citizens of Tanzania, Great Britain, Switzerland, and Turkey
- Persons who have a permanent residence permit in the aforementioned countries
- Foreign sportsmen and physical training specialists

Quarantine

Foreign citizens who enter Russia for the purpose of work and persons arriving by evacuation flights will have to self-isolate for 14 days.

When boarding the plane and when crossing Russian border, the foreign citizen must present negative test results for the Covid-19 test (done by PCR method). Such test must be done no later than 3 calendar days before arriving in Russia.

Before crossing the borders, foreign citizens will be required to fill the questionnaire for arrivals.

Azerbaijan

The Azerbaijani government has restricted the entrance of foreign citizens and has introduced quarantine regime in Baku and several other areas until August 31. However, there are some exceptions for entering the country. The following persons are exempted from the entry restriction:

- Foreigners who are spouses, children, or parents of an Azerbaijani citizen
- Holders of Azerbaijani residence permits (temporary and permanent residence cards, special passports)
- Foreigners with refugee status in Azerbaijan
- Representatives of diplomatic and consular offices, international organizations, and their family members
- Members of official delegations
- Airplane crew members

Quarantine

All persons entering Azerbaijan will have to self-isolate for 14 days, irrespective of the country of origin.

Armenia

Armenia has no restrictions on the entry of foreign nationals arriving via the airport, except for the mandatory quarantine.

Quarantine

All persons entering Armenia shall be subject to 14-day home quarantine, irrespective of the country of origin. However, they shall be allowed to undergo a polymerase chain reaction (PCR) test for the diagnosis of coronavirus disease (COVID-19). In case of a negative result, self-isolation is no longer required.
